

LEVEL 1 FIRE RESTRICTIONS



PROHIBITED

- ⊗ **ALL OPEN BURNING***
- ⊗ **CAMPFIRES*** (That are not on private lands or within improved/maintained campgrounds that are currently open to the public)
- ⊗ **WARMING FIRES**
- ⊗ **SLASH PILE BURNING**
- ⊗ **FIREWORKS**
- ⊗ **MODEL ROCKETS**
- ⊗ Use of **INTERNAL COMBUSTION ENGINES** without a spark-arresting device
- ⊗ **BLASTING**
- ⊗ **WELDING OUTDOORS**
- ⊗ Burning **TRASH** is illegal at **ALL TIMES**

ALLOWED

- ✓ **LIQUID FUEL STOVES**
- ✓ **GAS STOVES**
- ✓ **CHARCOAL GRILLS** on private property
- ✓ **CAMPFIRES*** On private lands and in USFS improved/maintained campgrounds that are currently open to the public.

Boulder County Ordinance

2018-1

AN ORDINANCE AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS OR THE SHERIFF OF BOULDER COUNTY TO DECLARE AN OPEN FIRE RESTRICTION "WHENEVER THE DANGER OF FOREST OR GRASS FIRES IS FOUND TO BE HIGH, AND WITHOUT FURTHER PROCEEDINGS OR RESOLUTION.

For the purposes of this order, "open fires" shall mean any activity that produces or maintains, or attempts to produce or maintain, spark or flame or ignition. "Open fires" does not include burning used for bonafide agricultural purposes by agricultural producers on their land, fires wholly contained within an enclosed building or vehicle that are used in a safe manner and that do not permit any flame, spark or burning or ignited material to exit such building or vehicle.

Any person who violates this fire restriction commits a class 2 petty offense and, upon conviction thereof, shall be punished by a fine of five hundred dollars (\$500) for a first offense, seven hundred and fifty dollars (\$750) for a second offense, and one thousand (\$1000) for a third and any subsequent offense. If you light a fire on a Red Flag warning day and it escapes to a neighbor's property, you can be charged with arson and be held financially responsible for the cost of fighting the fire and any damages.



DEFINITION

OPEN BURN - An open burn is any burn from which the smoke enters the ambient air without first passing through a chimney or scrubber.

CAMPFIRE - A single fire no larger than 2 feet length x 2 feet wide x 3 feet high that is contained by a fireplace or fire pit, which is used for cooking, personal warmth, lighting, ceremonial, or aesthetic purposes that is not within or mounted on any structure. Charcoal grills and gas stoves are considered campfires.
